

Dos and Don'ts

1. *Hostel accommodation and other infrastructural facilities shall be available only to our registered members.*
2. *Visitors of guests staying in rooms/dormitories are not permitted beyond the reception/lobby area.*
3. *Every guest is expected to follow the dining hall meal timings. Outside food and beverage / consumables are strictly not allowed in premises.*
4. *Please avoid wastage of food items. You may have multiple servings from the buffet/serving table as per your requirements.*
5. *Consumption of pan/tobacco/alcohol/drugs/cigarette and/or other intoxicating substances in the entire premises is strictly prohibited.*
6. *Guests shall maintain a high level of social and moral etiquette at all times, and shall not create any kind of nuisance to others in any manner whatsoever.*
7. *All are expected to maintain code of conduct within the premises of the hostel. Any misbehaviour, misconduct or breach of hostel rules and regulations may invite action, including, but not restricted to his/her expulsion from the hostel and/or cancellation of membership without notice. 8. In the hostel premises, the following activities are strictly prohibited: a) Gambling b) Intimidation or violence c) Entering the hostel premises in an intoxicated state d) Using abusive languages*
9. *Guests are advised not to climb onto parapets or the hostel roof.*
10. *Guests should not throw papers, plastics, etc. outside their rooms and common places. They are advised to use the garbage-bins for disposal of waste. They should not keep any belongings outside their rooms.*
11. *Guests / Event organisers shall not fix posters / notices / pictures / cello tape or anything that might damage the surface of the walls/doors or any place in the hostel premises.*
12. *Any kind of political campaign, political event, political function, or political gathering of any nature are not permissible in VYK campus. All events are subject to VYK norms and strict adherence to government directives and subject to all applicable laws. All promotional materials/banners/flyers relating to the event should be strictly in the name of the party/organisation booking the event and no deviation in the same shall be permitted.*
13. *Guest is expected to act in accordance to applicable norms and government policies.*
14. *Please note that our hostel does not offer laundry services. However, we are happy to provide information about nearby laundry facilities upon request. Thank you for your understanding."*
15. *Parking Policy: For security and space management reasons, outsiders are not permitted to park their vehicles on the hostel premises. We kindly ask all guests to adhere to this policy.*
16. *"Events and Decorators Policy:*
 - *Prior approval from hostel management is required for hosting any events on the premises.*
 - *Events should not disrupt the comfort and safety of other guests.*
 - *Noise levels must be kept to a minimum during quiet hours.*
 - *The hostel reserves the right to deny permission for events deemed inappropriate or disruptive.*
